The responsibility of EMPD and SAPS are to protect our communities against law breakers. The by laws cannot be applied where government does not have a plan to combat crime. Community members are gatvol of crime and have came with a best solution to the rising rate of crime with no response from law enforcers on time.

We will not fold our arms when our people's efforts are being undermined by Law enforcers using their power against our people.
